By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the website, or any of Services, immediately.
- (c) Raiden Technologies Pty Ltd reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Raiden Technologies Pty Ltd updates the Terms, it will use reasonable endeavors to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of publication. Before you continue, we recommend you keep a copy of the Terms for your records.

#### 2. Acceptance of the Terms

You accept the Terms by remaining on the website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Raiden Technologies Pty Ltd in the user interface.

## 3. Registration to use the Purchase Service

- (a) In order to access the Purchase Services, you must first register as a user of the Website. As part of the registration process, or as part of your continued use of the Purchase Services, you may be required to provide personal information about yourself (such as identification or contact details), including:

In using the Purchase Services, you warrant that you have familiarised yourself with, and agree to be bound by, the applicable Terms and Conditions of Use, Privacy Policy and other relevant legal documents provided by the Payments Gateway Providers.
- (c) Following payments of the Purchase Price being confirmed by Raiden Technologies Pty Ltd, you will be issued with a receipt to confirm that the payment has been receive and Raiden Technologies Pty Ltd may record your purchase details for future use.
- (d) Raiden Technologies Pty Ltd may, at their sole discretion, provide a refund on the return of the Products within 30 days where the Product packaging is unopened and remains in a saleable condition. You acknowledge and agree that you are liable for any postage and shipping costs associated with any refund pursuant to this clause.

## 6. Purchase of Products and Returns Policy

(a) Raiden Technologies Pty Ltd Products come with guarantees that cannot be excluded under the Australian Consumer law. You are entitled to a replacement or refund for a major failure of the Product and compensation for any other reasonably foreseeable loss or damage. You are entitled to have the

- (b) You may make a claim under this clause (Warranty Claim) for material defects and workmanship in the Product within 12 months from the date of purchase (Warranty Period).
- (c) In order to make a Warranty Claim during the Warranty Period, you must provide proof of purchase to Raiden Technologies Pty Ltd showing the sate of purchase of the Products, provide a description of the Products and the price paid for the Products by sending written notice to Raiden Technologies Pty Ltd by email at sales@raidentechnologies.com.au.
- (d) Where the Warranty Claim is accepted then Raiden Technologies Pty Ltd will, at its sole discretion, either repair or replace any defective Products or part thereof with a new or remanufactured equivalent during the Warranty Period at no Charge to you for parts or labour. You acknowledge and agree that you will be solely liable for any postage or shipping costs incurred in facilitating the Warranty Claim.
- (e) The Warranty shall be the sole and exclusive warranty granted by Raiden Technologies Pty Ltd and shall be the sole and exclusive remedy available to you in addition to other rights and under a law in relation to the Products to which this warranty relates.

- (d) Raiden Technologies Pty Ltd may at any time, terminate the Terms with you if:
  - you have breached any provision of the Terms or intend to breach any provision;
  - (ii) Raiden Technologies Pty Ltd is required to do so by law;
  - (iii) the partner with whom Raiden Technologies Pty Ltd offered the Purchase Services to you has terminated its relationship with Raiden Technologies Pty Ltd or ceased to offer the Purchase Services to you;
  - (iv) Raiden Technologies Pty Ltd is transitioning to no longer providing the Purchase Servies to Users in the country in which tou are resident or from which you use the service; or
  - (v) the provision of the Purchase Services to you by Raiden Technologies Pty Ltd is, in the opinion of Raiden Technologies Pty Ltd, no longer commercially viable.

## 13. Dispute Resolution

#### 13.1 Compulsory

If a dispute arises out of or relates to the terms, either party may not commence and tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

#### 13.2 Notice

A party to the Terms claiming a dispute (**Dispute**) has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

#### 13.3 Resolution

On receipt of that notice (**Notice**) by that other party, the parties to the Terms (**Parties**) must:

- Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (ii) If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Partied must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the \_\_\_\_\_\_ or his or her nominee;
- (iii) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with mediation; The mediation will be held in Sydney, Australia.

#### 13.4 Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

#### 13.5 Termination of Mediation

If 2 months have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to termiate the mediation and the mediator must do so.

## 14. Venue and Jurisdiction

The Purchase Services offered by Raiden Technologies Pty Ltd are intended to be used by residents of Australia. In the event of any dispute arising out of orin relation to the

Website, you agree that the exclusion venue for resolving any dispute shall be in the courts o New South Wales, Australia.

#### 15. Governing Law

The Terms are governed by the laws of New South Wales, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of New South Wales Australia, without reference to conflict of laws principle, notwithstanding mandatory riles. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

## 16. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
